<p>Republic of the Philippines COURT OF APPEALS Manila</p> <p>RESOLUTION NO. 3</p> <p>WHEREAS, the Court of Appeals advertised the Invitation to Bid for the Supply and Delivery of One (1) Unit Dental Chair, One (1) Unit Light Cure Machine, and One (1) Unit Autoclave Machine for the official use of the Medical and Dental Division of the Court in the Phil-GEPS, Court website and in conspicuous places in the Court compound on June 21, 2017.</p> <p>WHEREAS, in response to said advertisement two (2) contractors bought bid documents, namely: Pandora Equipment Specialist Corporation and Alphadent Corporation who submitted their respective bid proposals for said project on July 17, 2017 but were declared ineligible for the following reasons:</p> <p>Pandora Equipment Specialist Corp. was declared ineligible because it failed to include in its eligibility documents a Statement of On-going and Single Largest Contract which should be equivalent to at least fifty percent (50%) of the ABC.</p> <p>Alphadent Corp. was declared ineligible for failure to attach its Articles of Incorporation to its SEC Registration Certification as required.</p>			

WHEREAS, both contractors were given three (3) days from notice within which to file a Motion for Reconsideration stating the reason for their failure and attaching the missing documents through their respective representatives who were warned that failure to comply will be considered loss of interest in pursuing their respective bid proposals.

WHEREAS, on July 20, 2017, only Pandora Equipment Specialist Corporation filed its motion for reconsideration with the Secretariat while Alphadent sent its representative informing the Committee that they will not be able to comply with the requirement within the specified period.

WHEREAS, the Committee granted Pandora Equipment Specialist Corporation's motion for reconsideration and set the continuation of the opening of its bid proposal on August 02, 2017 at 2:30 o'clock in the afternoon giving notice to all concerned.

WHEREAS, on said date and time, the Committee declared Pandora to have "Failed" for its failure to comply with the requirement that states: "The Bidder must have completed, within the period specified in the Invitation to Bid and ITB Clause 12.1(a)(ii), a single contract that is similar to this Project,"

WHEREAS, the Committee declared a Failure of Bidding for the Supply and Delivery of One (1) Unit Dental Chair, One (1) Unit Light Cure Machine and One (1) Unit Autoclave Machine for the official use of the Medical and Dental Division of the Court and recommended to Hon. Remedios A. Salazar-Fernando, Acting Presiding Justice the second posting of the Invitation to Bid in the Phil-GEPS, Court website and in conspicuous places inside the Court Compound on August 11, 2017 which the latter granted.

WHEREAS, in response to the second Invitation to Bid, Surgicom Tading Corporation purchased bid documents and filed its bid proposal on September 04, 2017.

WHEREAS, the Technical Committee was directed to further evaluate the bid proposal submitted by said contractor, to conduct an on-site verification of its office premises and to submit its findings in due time.

WHEREAS, on October 05, 2017, the Technical Committee submitted its findings, to wit:

- 1) The address submitted by Surgicom Trading Corporation turned out to be a warehouse/stockroom for dental supplies;
- 2) There was no display of any dental chair and other dental machines such that they were not able to examine the equipment proposed by the said contractor;
- 3) When Dr. Joan inquired if they have already ordered the required dental equipment, the owner replied that importing only one unit is impossible.

WHEREAS, the Technical Committee surveyed the market for the aforesaid dental equipment and submitted its findings and recommendation on December 11, 2017 finding that European/American made dental machines were of better quality at a lesser price than Surgicom's offer.

WHEREAS, considering the foregoing circumstances, the Committee resolved to disqualify Surgicom Trading Corporation and to declare a second failure of bidding for the supply and delivery of One (1) Unit Dental Chair, One (1) Unit Light Cure Machine, and One (1) Unit Autoclave Machine for the official use of the Medical and Dental Division of the Court and hereby recommends to Presiding Justice Romeo F. Barza that the Court resort to Negotiated Procurement pursuant to Section 53 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act.

Pandora Equipment Specialist Corp. was declared ineligible because it failed to include in its eligibility documents a Statement of On-going and Single Largest Contract which should be equivalent to at least fifty percent (50%) of the ABC.

Alphadent Corp. was declared ineligible for failure to attach its Articles of Incorporation to its SEC Registration Certification as required.

WHEREAS, both contractors were given three (3) days from notice within which to file a Motion for Reconsideration stating the reason for their failure and attaching the missing documents through their respective representatives who
