INVITATION TO BID
For the
Supply and Delivery of One (1) Unit Dental Chair,
One (1) Unit Light Cure Machine,
and One (1) Unit Autoclave Machine
(SECOND POSTING)

1. The Court of Appeals, through its Appropriations under Continuing Appropriation for Capital Outlay – Medical Equipment Outlay intends to apply the sum of **P1,100,000.00** being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of One (1) Dental Chair, One (1) Unit Light Cure Machine, and One (1) Unit Autoclave Machine. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Court of Appeals through its Bids and Awards Committee now invites bids for the Supply and Delivery of One (1) Dental Chair, One (1) Unit Light Cure Machine, and One (1) Unit Autoclave Machine with an approved budget of **P1,100,000.00**.

Delivery of the said dental supplies is required thirty (30) days after receipt of P.O. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the BAC Secretariat, c/o Office of the Clerk of Court and inspect the Bidding Documents at the address given below during office hours from **8:00A.M.-4:30P.M.**

5. A complete set of Bidding Documents may be acquired by interested Bidders on **August 11, 2017** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **P1,000.00**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Court of Appeals, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Court of Appeals through its Bids and Awards Committee will hold a Pre-Bid Conference on **August 23, 2017 at 2:30 P.M.** at the CA-Auditorium, Ground Floor, Centennial Building which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **September 04, 2017 from 8:00 A.M.-2:00 P.M.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **September 04, 2017 at 2:30 P.M.** at the CA-Auditorium, Ground Floor, Centennial Bldg. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The Court of Appeals reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
