RESOLUTION NO. 4


WHEREAS, the Court of Appeals advertised the Invitation to Bid for the Supply and Delivery of Two (2) Units VAN TCI M/T 12-Seater (Lot 1) and Eight (8) Units SUV 4x2 G A/T DSL (Lot 2) for the official use of Ten (10) Associate Justices of the Court with an approved budget of P1,400,000.00 per unit or a total P14,000,000.00 in the Philippine Business Daily Mirror, PhilGEPS, Court Website and in conspicuous places in the Court compound on February 19, 2016;

WHEREAS, not one contractor responded to said advertisement, none purchased bid documents nor filed bid proposals for the aforementioned units, hence, the Committee declared a failure of bidding and recommended to Presiding Justice Andres B. Reyes, Jr. the re-posting of the Invitation to Bid in the PhilGEPS, Court Website and in conspicuous places in the Court Compound;

WHEREAS, Presiding Justice Andres B. Reyes, Jr., approved the Committee's recommendation such that said Invitation to Bid was re-posted in the PhilGEPS, Court Website and in conspicuous places in the Court compound;

WHEREAS, Toyota Pasong Tamo bought bid documents and subsequently submitted its bid proposal for the Supply and Delivery of Eight (8) Units SUV 4x2 G A/T DSL (Lot 2) while none bought bid documents nor filed bid proposal for Lot 1 which prompted the Committee to declare a second failure of bidding;

WHEREAS, having passed all the eligibility, technical and financial requirements, the Committee found Toyota Pasong Tamo, Inc. to have passed post-qualification and was eventually declared the winning bidder for the Supply and Delivery of Eight (8) Units SUV 4x2 G A/T DSL (Lot 2);




WHEREAS, the Justices to whom Lot 1 will be assigned, upon being informed that there was a second failure of bidding requested for a change of specifications of their vehicle of choice from VAN TCI M/T 12-Seater to VAN TCI M/T 10-Seater;

WHEREFORE, the Committee Resolved to Recommend to Presiding Justice Andres B. Reyes, Jr. to resort to Negotiated Procurement for the Supply and Delivery of Two (2) Units VAN TCI M/T 10-Seater.
