OFFICE ORDER NO. 40-12-ABR-1

In Office Order No. 40-12-ABR effective February 15, 2012, the reorganization of the Divisions was effected with the compulsory retirement of Justice Josefina Guevara-Salonga pursuant to Sections 1 and 9 Rule 1 of the 2009 Internal Rules of the Court of Appeals.
